# **Strategic Planning Session**

Earlier this year the NCWRPC under took a Strategic Planning Session to begin developing a five year organizational plan. Commissioners and invited guests conducted a facilitated workshop to identify issues and develop strategic goals, strategies, and action steps to address those issues. This is something that the organization does every five years.

To conduct the strategic planning process, participants: engaged in a regional community visioning exercise from both an organizational and personal perspective; conducted a Strengths-Weaknesses-Opportunities-Threats (SWOT) analysis that identified organizational strengths, weaknesses, opportunities, and threats; analyzed relevant internal and external cultural trends and challenges; and created five strategic goals, with accompanying strategies and action steps.

Participants identified five strategic goals:

- 1. Adapt to change
- 2. Increase funding
- 3. Improve communication
- 4. Maintain county (member) support
- 5. Assist overstretched staff

# Census Numbers Released

Every ten years the US Census Bureau undertakes the task of counting every person in our nation. The information from the 2010 Census is just starting to be released.

There have been substantial changes in our region over the last ten years. The fast paced growth of the 90's has been replaced by very slow and declining



growth in our region. In 2000, when the last Census took place, our ten county region had a population of 431,021 or about 8 percent of the state's total population. In 2010 our overall regional population increased to 441,822, a 2.5 percent increase, and still makes up about 8 percent of the state's population.



Between 2000 and 2010, five counties lost population, while five gained population. Generally, the northern counties experienced a decrease, although Wood County also lost population, while Vilas County grew slightly. This is a stark contrast to the previous decade (1990 to 2000) where all ten counties experienced growing populations. Juneau County led the way with nearly 10 percent growth, but much of that can be attributed to the opening of two correctional facilities. Marathon County was the only other county in the region to outpace with state growth rate, increasing by 6.5 percent vs. 6

percent state growth. Meanwhile, Adams and Portage had population increases over 4 percent.

# Pavement Rating Assistance Available

It is time once again for local governments in Wisconsin to submit surface condition ratings for all local roads under their jurisdiction. State statute 86.302(2) requires that the ratings be submitted to the Wisconsin Department of Transportation every two years. In 2009, the NCWRPC submitted the mandated condition ratings for 20 communities. The next round of submissions will be due to WisDOT by December of this year.

Commission staff will be providing a variety of services to local units of government within the Region to meet their needs for pavement rating and submitting to WisDOT. Most of these services will be provided free-of-charge to Commission members while non-members will be charged for assistance per our 2011-2012 fee schedule. # **Traffic Counting Services**

The NCWRPC will again be offering traffic counting services to member units of government this summer. Last year, traffic counts were completed for the Village of Friendship in Adams County, the Town of Ainsworth and Rolling in Langlade County and the Town of Cassian in Oneida County. Our counter can provide basic traffic counts and average traffic statistics. The equipment can also provide vehicle classification statistics – whether it is a car or a truck and even what type of truck. Traffic may also be broken down by time of day. Speed statistics are also possible which may be of assistance in setting speed limits or identifying speeding trouble spots.

# Mosinee's Downtown Plan

The City of Mosinee is in the final stages of planning for their downtown. Community leaders identified the need for a downtown development plan and asked the NCWRPC for assistance.

The downtown development plan comprises five main chapters: Introduction, Current Land Use Assessment, Transportation, Downtown Development Plan, and Implementation. The Introduction explains the purpose for this plan identifies goals and reviews previous plans that impacted the downtown planning area. The Current Land Use Assessment classifies the current land uses in the downtown area by type. This section also looks at property values and business by type to understand the current dynamics of the downtown area. The Transportation section examines traffic circulation, downtown parking analysis, and examines bicycle and pedestrian access and connectivity. The Downtown Development Plan section reviews each block in the downtown planning area and prioritizes areas for development by creating phases for development. Implementation provides action steps to explore the development opportunities as well as identifing sources of funding to aid in development.

# Facade Improvement Loan

The North Central Wisconsin Development Corporation (NCWDC) recently awarded a facade improvement loan to Hodag Development Group LLC. The loan will help complete facade improvements to the old Ben Franklin building located at 51 Brown Street in downtown Rhinelander. Currently Rhinelander is one of five central business districts in the region that has applied for the funds.

The facade improvement program is part of the Community Development Loan Fund administered by the North Central Wisconsin Development Corporation. The facade improvement program is intended to help properties in eligible central business districts complete building facade improvements, tuckpointing, brick restoration, awning repair or installation, signage and facade painting. Facade improvement loan requests require a private match equal to the loan amount up to \$7,500; they have an interest rate of 4% and are required to be paid back within 5 years. The Community Development Loan Fund also provides a micro-loan program, and a job creation and retention program. Currently NCWDC has money available to consider loans for all programs in the community development Loan fund.



The North Central Wisconsin Development Corporation (NCWDC) is a 501c(3) non-stock, non-profit corporation established in 1994 with a revolving loan fund. Money from the fund provides gap financing to eligible businesses. North Central Wisconsin Regional Planning Commission manages the fund.
