# **Commission Meeting Highlights**

The Fall Meeting of the North Central Wisconsin Regional Planning Commission was highlighted by change of leadership, for the first time since 1984, review of program areas, and adoption of the 2014 Budget.

Bettye Nall was elected as Chairperson of the NCWRPC to fill out the term of Erhard Huettl, who passed away late last summer; he had served as Chair since 1984. Paul Millan was elected Vice-Chair replacing Bettye, who had served in that role since 2005. They join Secretary-Treasurer George Bornemann as the organizations officers. All three will be up for re-election in April. Terms are two years.

Staff provided updates for each of the five NCWRPC program areas of economic development, GIS & mapping, intergovernmental cooperation, land use, and transportation. Over 70 projects were highlighted. Economic Development projects highlighted included the update of the Regional Comprehensive Economic Development Strategy, local EMSI assistance, and the North Central Wisconsin Development Corporation Loan Funds. GIS & Mapping projects highlighted many mapping efforts. Intergovernmental projects included WROC, NEWCOM, and NC RIC. Land Use projects were many; some of the major projects highlighted were the Regional Livability Plan, Oneida and Vilas County Outdoor Recreation Plans, and Adams and Forest All Hazard Mitigation Plans. The final program area of Transportation highlighted the completion of Specialized Transit Plans for each county, Adams County Bike and Pedestrian Plan, the Northwoods Rail Coalition, a detailed Merrill Area Transportation Planning Study, and over 20 local WISLR Ratings.


The 2014 Annual Budget was approved. The budget contains three primary sources of revenue. The levy membership charge is expected to collect \$237,000 (decreased 1.5% from last year), continuing EDA & DOT grants will total \$136,400 (the same as last year), and project revenues will collect about \$485,800 (up from last year). Overall total budget is expected to be about \$860,000. The goal of lowering the cost of membership was again met. Budget growth is based on securing grants and other projects for members throughout the region.

# Regional Livability Plan Update

The NCWRPC has been working to prepare a Regional Livability Plan (RLP). This plan will update the 2003 Regional Comprehensive Plan and lay the foundation for the principles of livability throughout our Region. The RLP will examine economic development, housing, land use, and transportation we can become a more livable and sustainable region.

The Regional Livability Oversight Committee has been meeting quarterly to review various work product of this effort. Recently the committee has reviewed the demographics and issues report, and drafts of the Housing and Economic Development Assessment Reports. Both Assessment Reports include statistical information and trends, livability goals and objectives, and performance measures. The next quarterly meeting of the committee will be held in March.



The result of this planning effort will be a Demographic Report, four Assessment Reports (Transportation, Economic Development, Housing, & Land Use) and a Regional Livability Plan. More information is available at www.ncwrpc.org/rlp/.

# Transportation Coordination Plans Completed

During 2013, the NCWRPC, at the request of the Wisconsin Department of Transportation (WisDOT) and with input from human services agencies and public and private transit operators in each county, facilitated the planning process and prepared Public Transit-Human Services Transportation Coordination Plans or "Coordination Plans" for each of the ten counties in the Region.

Coordination Plans are intended to provide a framework to assist community leaders, human services agencies, and public transit agencies to improve transportation services in each county and between counties. The 2013 Coordination Plans assess the existing transportation needs and services in each county, identify unmet needs or service gaps, and present a prioritized list of strategies to address those needs. Each County's coordination plan may be viewed and downloaded from the NCWRPC website.

These Coordination Plans were prepared in response to Federal Transit Administration (FTA) regulations. Transit projects using funds from the FTA's Enhanced Mobility for of Seniors and Individuals with Disabilities Program (Section 5310) must be derived from a locally-developed plan for public transit and human services transportation coordination. The Section 5310 program funds assist with the purchase of specialized transit vehicles used to serve elderly and disabled persons, and provide capital and operating assistance for public transportation services that go beyond the requirements of the Americans with Disabilities Act.

To complete the public transit-human services transportation plans, NCWRPC staff conducted an assessment of transportation needs for individuals with disabilities and seniors including an inventory of available transportation services and identified strategies to address the identified gaps between current services and needs.

# Road Surface Management Planning Assistance Available

The NCWRPC has prepared over 80 local road surface management plans for towns, villages, cities and counties throughout the Region. A road surface management plan determines maintenance needs and sets priorities used to establish maintenance and a capital improvements schedule for the local roads within a jurisdiction.

NCWRPC staff lists which road segments need work, the type of work needed, a time schedule within which the work should be carried out, and an estimated budget. These plans systematically relate road needs to dollars available; and make managing local roadway systems easier, faster and more consistent. WisDOT's Local Road Improvement Program (LRIP), one of the primary grant programs available for improving local roads, requires a road surface management plan for a community project to be eligible for funding.

The NCWRPC has again partnered with the Wisconsin Economic Development Corporation (WEDC) to provide economic development analysis data throughout the region.

Acomprehensive economic modeling program, called Analyst, developed by Economic Modeling Specialists International is a tool that provides industry/occupation data, impact assessments, and economic base analysis information.
