RE: Traffic Count Report

The Town of Cassian requested traffic counting services from the North Central Wisconsin Regional Planning Commission for three locations within the Town. These locations are described in Table 1.

Count #	Count Location	Location Description	Counting Period
1	Lakewood Rd	Just South of Rocky Run Rd	Tue-Thur 7/30 - 8/8
2	Lakewood Rd	Just North of Rocky Run Rd	Fri-Thur 8/9 - 8/15
3	Harshaw Rd	Just West of Clovervalley Rd	Fri-Mon 8/16 - 8/19

The Town requested general information with regard to traffic volumes on these roads. The attached reports summarize the data from these sites. For each location, there is a vehicle volume report, with average hourly vehicle counts by lane direction and totals for the counting period, a combined speed report with totals combined for both directions by speed group and time, and a combined classification report with totals combined for both directions by type of vehicle and time.

At count one, on Lakewood Road, traffic averages about 454 vehicles per day. The majority of vehicles counted were cars and pick-ups with about 9.5% 2-axle/6 tire trucks and a small percentage of larger trucks. Average speed over the counting period was about 46 mph.

At count two, on Lakewood Road, traffic averages about 497 vehicles per day. The majority of vehicles counted were cars and pick-ups with about 10.5% 2-axle/6 tire trucks and a small percentage of larger trucks. Average speed over the counting period was about 40 mph.

At count three, on Harshaw Road, traffic averages about 150 vehicles per day. The majority of vehicles counted were cars and pick-ups with about 2.4% 2-axle/6 tire trucks. Average speed over the counting period was about 35 mph.
