






# Q2 Local units of government have a responsibility to protect public health, safety, and general welfare by regulating land use.





### Q4 The following types of development should be encouraged within Portage County (select all that apply):












### Q7 New homes and businesses should be encouraged (select one):





## Q9 How would you rate the current groundwater quality in Portage County?





# Q10 Do you think Portage County's groundwater quality has changed in the past 10 years?






